One building covering 8000 square feet of ground floor and approximately 2400 square feet of open second floor/mezzanine space is proposed. Proposed height is 56 feet. Primary use of space is indoor climbing (recreation), less than 10% of space would be used for retail sales. Proposed building would be clad in metal siding similar in character to existing adjacent buildings. We will share the current 114 parking spaces with the current recreational facilities and propose to add an additional 61 spaces by lining existing paved area. No additional paving is currently proposed.


