Brief Description of Proposed Action (include purpose or need): The proposed action include the development of 72 apartment units in 9 buildings, and a 3100 SF community center, with associated parking roadways and utilities on ±13.5 acres of the Town of Lansing's Auburn Road ±22.4 acres Parcel "C". The project will also include the installation of an on site package wastewater treatment plant to handle sanitary flows from the project. Stormwater management for the site includes a pond as well as vegetated swales and other green infrastructure improvements to treat stormwater runoff from the site. The project will also include the construction of about 600 LF of dedicated road to gain access to the site from Auburn Road. This will also include a water main extension from Auburn road to the to the southerly project entrance to serve the site's domestic and fire water needs. Phase II of the project will be a continuation of Phase I, and will be located on ±8.9 acres/the remaining lands of Parcel "C". This phase will consist of 56 apartment units, a community center and will be serves by its own stormwater management facilities and package treatment plant. The water for this phase will consist of a new main that will be extended from Phase I.

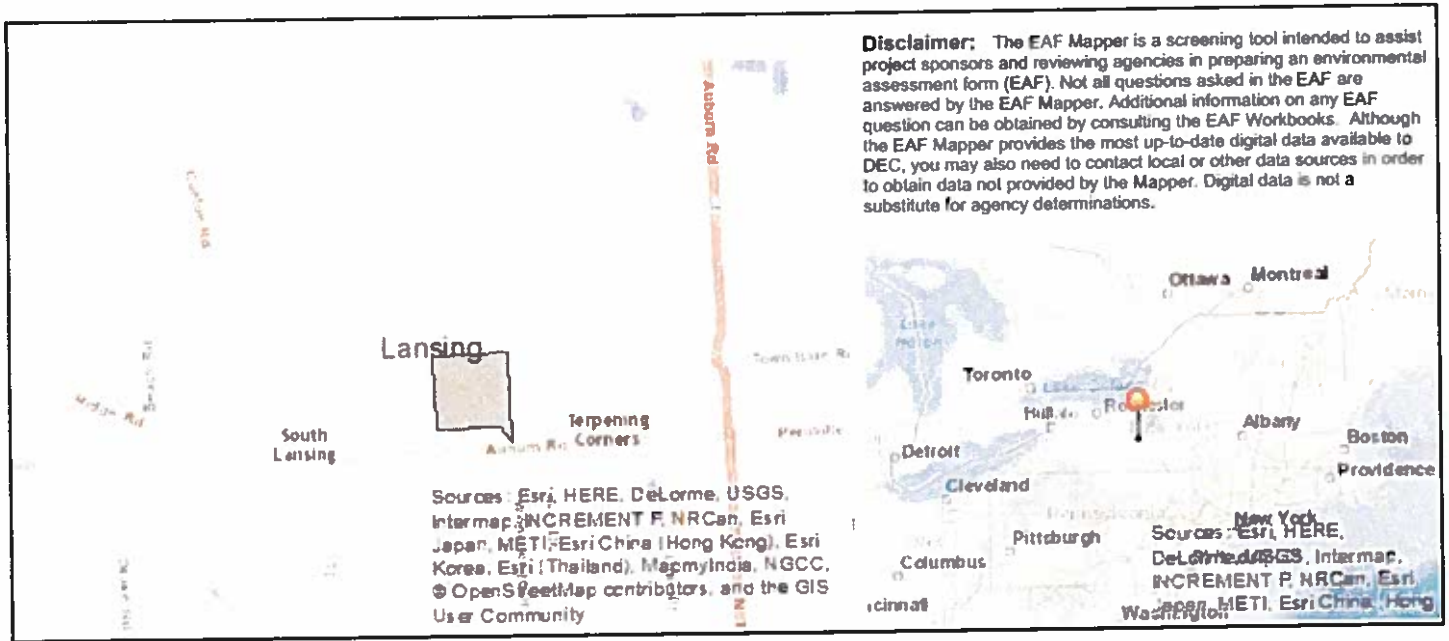

Engineer's Report

Lansing Trails Apartments - Auburn Road Parcel "C" – Town of Lansing, NY

7.3 *Gas & Electric*

There is no available natural gas near the project site. As a result, the project will incorporate electric appliances and mechanical devices. There is overhead electric on Auburn Road. The extension of power lines or underground electric to the site will require coordination with NYSEG early on in the project is recommended, as review and design processes can be lengthy. Loading information will be provided to the utility company as the design of the buildings and site progresses.

8.0 TRAFFIC & ACCESS

Access to the project site will be via a new dedicated Town road that will be constructed as part of this project. The road will connect to Auburn Road, which is a NYSDOT roadway.

The maximum number of vehicles entering and exiting the site has been determined using the Institution of Transportation Engineers (ITE) Trip Generation Manual, 9th Edition, *Land Use Group 221 – Low Rise Apartments*:

The trips generated during the peak hour of phase I and full buildout scenarios are less than the 100-trip threshold required by NYSDOT to conduct a traffic study. Site distance at the proposed intersection is >1,000 ft. in the easterly and westerly directions.

The proposed Town dedicated road is currently proposed to align with Woodsedge Drive on the south side of Auburn Road. The road will be designed to comply with all Town standards and NYSDOT standards with regard to its connection to Auburn Road. The project will seek all necessary permits from NYSDOT, which entails a review and approval process with the regional and residence offices.

1. Part B— regional or county agency should list the § 239 review as required. **EAF has been revised to include this.**
2. Part B—I believe the Town does have a Local Waterfront Revitalization Program, at least jointly with others in the County. **This was completed by the EAF mapper, and was automatically checked no. I did some digging and couldn't find anything one way or the other.**
3. Part D.1.—correctly identifies the need for a subdivision of Parcel C, but Parcel C must also be subdivided from the Town's main parcel. **We added some verbiage in the EAF noting that Parcel C is to be subdivided from the ±150 acres Town Center Parcel.**
4. Part D.2.j.—I am not sure about the no significant traffic impact reply and would defer to others, but I did not see any intersection analysis or traffic study. I understand that some rule says 100 or 200 vehicles, but SEQRA is site-specific and guidelines are only a part of the equation. As this issue is blowing up in a neighboring community, perhaps we'd be wise to avoid the problem, particularly as I do not think we can (or should not, perhaps) look at traffic only on a project-by-project basis and not consider the whole-site impacts, including due to the fact that we intend to interconnect the sites. **You are correct, in terms of the number of trips. NYSDOT does not require a traffic study for a project that generates less than 100 trips. However, we have performed a generic traffic analysis of the project, at full build, which shows that the project will generate less than 100**

trips during the peak hour (it is noted in the engineer's report). Since this is the first project proposed for the development, there will be little to no impact the adjacent road network. We say this based on our calculations completed, that stem from standard engineering practices and the ITE manual and based on our past experience designing projects of similar size that connect to roads such as Auburn Road having similar traffic patterns.

5. Part D.2.k is unanswered. This has been revised and answered.
6. Part D.2.m. has a reference to a "local Town ordinance" and I am unsure if this is a stock/rote answer or if they are referencing something specific. This is a response we provided. Basically stating that construction equipment will only be operated during times allowed by Town code. We have revised its to also indicate that equipment will only be run between 7 am and 7 pm.
7. Part D.2.o. appears to be incorrect. The project will not produce odors. The only odor emitting facility on site could be the WWTP, however the plant employs measures to mitigate odors.
8. Part D.2.r. is unanswered. This has been answered as no.
9. This appears not to have been generated by the EAF Mapper, please use that system as the town attorney certainly will use it. The form was generated by EAF mapper. It is missing the last page showing the parcel map. I have attached a version I just downloaded from DEC's website for your use (I did not complete it, just wanted to provide as a reference).
